Since this award includes all of Southeast Region, any individual who was a member of any SER unit during the award period is authorized to wear the green Unit Citation Award ribbon (or an appropriate device per CAPR 39-3 paragraph 6b if they are already authorized to wear the ribbon). Individuals who were not members of one of those units during the award period are not authorized to wear the ribbon, even if they later join or transfer into one of those units.
3. This memorandum with attachment should be posted to members' personnel records as documentation of their eligibility to wear the ribbon.
4. Thank you all for your contributions to the successes we've had as a wing and region. The award of the unit citation to every member of the region over a period of four years reflects your continued commitment to excellence and your strong performance as volunteer professionals. 
